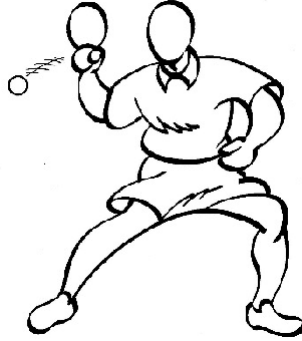

Tournament Format: All events are round robin followed by single elimination. Director reserves the right to modify or cancel events based on the number of entries- if canceled, players will be notified the night before the event starting time. Players who arrive 15 minutes after his/her event start time will be defaulted without refunds. Prizes will be awarded for the champion and runner-up in each division. Semifinals and final are best 3 out of 5. All other matches are best 2 out of 3.

Entry Deadline: Entry must be received by **Friday, April 5, 2019**. Entries received late will be accepted with a \$5 late fee or will be rejected based on available space.

Check-in: Starts at **8:45am on Saturday**. Players should check in 30 minutes prior to their first event.
